

Steamboat Reading, Inc.
Accident Waiver & Release of Liability

In consideration of the services of Steamboat Reading, Inc., their agents, owners, officers, volunteers, participants, employees, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as “Steamboat Reading”), I hereby agree to release and discharge Steamboat Reading, on behalf of my minor child, my children, my parents, my heirs, assigns, personal representative, and estate as follows:

1. **Indemnification:** I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Steamboat Reading from all claims, demands, or causes of action, which are in any way connected with my minor child’s participation in Steamboat Reading activities.
2. **Reimbursement:** I agree to reimburse Steamboat Reading for any and all damages caused by my minor child to real or personal property, regardless of whether the property damaged is owned by Steamboat Reading.
3. **Loss of Personal Property:** I agree to waive, release, and discharge Steamboat Reading as well as any of its assigns for the loss or theft of any of my minor child’s property. My minor child is responsible for his/her belongings while he/she is under the supervision of Steamboat Reading.
4. **Handbook Policies:** I have received the Steamboat Reading Family Handbook (“Handbook”) and reviewed it with my minor child. I agree to comply with the rules and regulations as stated in the Handbook. I further acknowledge that I and my minor child are aware of the circumstances which would result in my minor child’s dismissal from Steamboat Reading activities.
5. **Permission:** I understand that all activities will take place at 100 Park Ave., Suite 203, Steamboat Springs, Colorado. I give permission for my child to be transported by Steamboat Reading in a private licensed vehicle in the case of an emergency.
6. **Attorney’s Fees:** Should Steamboat Reading or anyone acting on their behalf be required to incur attorney’s fees and costs to enforce this agreement, I agree to pay Steamboat Reading’s reasonable costs of attorneys’ fees thereby expended.
7. **Emergency Authorization:** After reasonable attempts to contact the minor child’s parent(s) or guardian(s) have been made without success, I authorize Steamboat Reading to secure emergency medical and/or surgical treatment for my minor child while in their care. If emergency medical care is needed, my minor child will be transported to Yampa Valley Medical Center in Steamboat Springs, Colorado. For non-emergency medical care, my minor child will be transported to Steamboat Medical Center. I will accept all expenses of such care including fees for an ambulance.
8. **Applicable Law and Venue:** In the event of a dispute, I agree that the appropriate venue shall only be the courts of Routt County, Colorado, and that the substantive law of Colorado shall apply.
9. **Severability:** I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
10. **Binding:** This agreement is binding upon me and upon my spouse, heirs, assigns, dependents, personal representatives, attorneys, and my estates. This agreement is also binding upon my child or children on whose behalf it is executed and upon any legal guardian thereof.
11. **Scope:** I agree and understand that this Accident Waiver & Release of Liability shall be construed broadly to provide a release and waiver to the maximum extent possible under applicable law.
